**REQUEST FOR PERMISSION TO REPRODUCE OR PUBLISH

I/We agree to these stipulations **(Please read carefully and thoroughly):**

1. Written permission must be secured from the Highline Historical society to exhibit, resale, publish, or reproduce in any form, any photographic images/architectural drawings obtained directly or indirectly from the Historical Society. Permission is granted for one-time mutually agreed upon use(s) only. All other rights, including those of further reproduction or publication, are reserved in full by the Highline Historical Society.
2. All photographic images/architectural drawings obtained from the Highline Historical Society for temporary exhibit display, publication and/or any other form of reproduction are subject to normal fees but are considered to be on loan only and shall be returned to the Historical Society after their agreed upon one-time single or multiple use. All photographic materials are to be returned within three months unless agreed otherwise. A replacement fee shall be charged for images/architectural drawings not returned within the agreed upon time period.

3. All efforts should be made to make reproductions as faithful and accurate as possible. Alteration in reproductions of photographs are subject to prior review and/or approval. All reproductions, in any form, produced directly or indirectly from images/architectural drawings acquired through the Highline Historical Society are bound under the original agreement(s) under which the original materials (Historical Society images/architectural drawings) were obtained.
4. Credits: The following basic credit line is required for all reproductions of photographs: "Image/Drawing #, Collections Name, Highline Historical Society."
 - A) With printed matter, it is preferred that the credit line appear on the same or facing page as the illustrations or with other "sources of illustrations." Crediting of each individual image is necessary in all cases.
 - B) With films, filmstrips, and video use, include the credit with other "sources of illustrations." In manuals that accompany filmstrips, give credit at the point where the illustration is discussed.
 - C) With displays and exhibitions, show credit with each photograph.
5. Publishers, advertisers, film-video producers, and other's reproducing in any other format, shall furnish the Highline Historical Society WITHOUT CHARGE, one (1) copy of each item, advertisement, publication, book, 1/2 inch video or 35 mm slide of that which reproduction appears.
6. The Historical Society gives no exclusive rights to any publisher, author, or photographer, and assumes no responsibility for duplication of subjects by others and no responsibility for claims by third parties.
7. The Highline Historical Society can grant the permission requested only to the extent of its ownership of the item relating to the request. Photographs may be protected by copyright, trademark, or related interests not owned by the Society. The responsibility for ascertaining whether any such rights exist and for obtaining all other necessary permissions rests with the applicant.
8. The Applicant further agrees to define, indemnify, and hold the Highline Historical Society harmless as to any actual or alleged copyright infringement or related claims.
